We recognize suppliers as diverse when they are certified by third-party agencies as businesses that are 51% owned, operated and controlled by diverse individuals. Diverse groups include: women; minorities; veterans; people with disabilities, and LGBTQ.

FIELD ENGINEERING AND CONSTRUCTION SERVICES NEEDS

We have opportunities for suppliers to provide labor services that support Charter's Field Engineering and Construction teams, who enable the development, construction and maintenance of our network (plant).

FIELD ENGINEERING SERVICES

Field Engineering services consist of work activities that support: *pole engineering*, which utilizes the pole owner's required software application (such as Ocalc, Spanmaster, Spidacalc); *permitting* for poles, rights of way, bridges, and railroads; and *plant walkouts*, which involves mapping of current and proposed wireline network plant.

CONSTRUCTION SERVICES

Construction services consist of work activity that supports both *aerial* and *underground construction*. *Aerial construction* activities include fiber/coax/equipment placement via ground and bucket truck activity on utility poles. *Underground construction* activities include fiber/coax/equipment placement via bore, trench, plow or missile activity. Both construction types involve fiber splicing to facilitate specific fiber lengths and equipment placement.

LABOR SERVICES PROVIDER REQUIREMENTS

Suppliers who wish to provide labor services to Charter must meet all the requirements outlined below, and provide your company's documentation for the following:

- Written quality assurance program
- OSHA Summary of Work-Related Injuries and Illnesses for the past five years (OSHA 200 Summary and OSHA 300A – Summary as applicable)
- Safety meeting attendance sheets for the past 12 months
- Safety manual and written safety program
- DOT Compliance Program for Regulated Commercial Motor Vehicles
- Experienced Modification Rates (EMRs) for the past three years (assigned value related to worker's compensation coverage based on the losses the insurer has experienced from that employer)
- Pre-employment background check policy
- Pre-employment drug test policy
- Drug policy and alcohol abuse policy and program
- Written technical training program

MINIMUM FINANCIAL REQUIREMENTS

Companies must provide a minimum mix of 70% W-2s for 1099 workers.

MINIMUM INSURANCE REQUIREMENTS

• General Liability Coverage: \$2 million

Business Auto: \$1 millionWorkers Comp: \$1 million

If a provider has the skilled resources required, but cannot meet the aforementioned requirements, they may be eligible to become a Tier 2 subcontractor.
